

## Sprit Crime Assessment Form



This purpose of this questionnaire is for the assessment of Spirit Crime as reported by an individual, group, public or privately owned company or corporation. It is not necessary to divulge all the particulars if some information is considered proprietary, sensitive, or otherwise viewed as an invasion of privacy. However, the greater the detail the more effectively the Spirit Crime in question may be evaluated. Answers can be simple or detailed as seen fit.

Stopspiritcrime is not a legal firm nor has the power to provide legal advice. This questionnaire is designed to help outline the particular case of Spirit Crime being reported. It is sometimes difficult to consider all the ramifications of Spirit Crime, and these questions cover the primary points of interest to get started with a proper evaluation. The questionnaire is divided into four parts.

### Part 1:

What is the nature of the Spirit Crime? Please specify what has happened in your own words, or the impression of the company or corporation you represent:

Who was the victim of the alleged Spirit Crime? For instance was the victim an individual, a group of persons, a company or corporation? Please specify the victim of this alleged Spirit Crime by name:

If the victim is an individual, are they of legal age in your state?

If the victim is an underage individual, have child protective services become involved? Please specify the outcome if this is the case:

Does the Spirit Crime in question have particular temporal component(s) that are of relevance? For instance, specify the date of the alleged Spirit Crime and where it took place:

Was the alleged Spirit Crime occurrence a single event, spread out of a period of time, intermittent, or ongoing to this moment? Please specify the time frame(s):

Does the Spirit Crime in question have particular corporeal component(s) that are of relevance? For instance, specify physical changes made to, or affected upon the victim of the alleged Spirit Crime:

Who or what instigated the Spirit Crime for this case? Was the alleged Spirit Crime committed by another individual, group, company or corporation? Was the alleged Spirit Crime an event, gathering, social activity, or newly formed law? In your own words, or the impression of the company or corporation you represent, who or what is at fault for the alleged Spirit Crime?

Does the perpetrator of the alleged Spirit Crime have affiliations with special interests groups, companies, or corporations that have a historical precedence for committing Spirit Crime against individuals, other groups, companies or corporations?

Is there an expectation of motive behind the Spirit Crime in question? For example, was the alleged Spirit Crime committed with purpose in the moment, through premeditation, incidental to the circumstances, through mission of inaction, or possibly by accident? Please specify in your own words, or the impression of the company or corporation you represent the reason the Spirit Crime occurred in the first place:

**Part 2:**

Has there been a loss of revenue as a result of the alleged Spirit Crime?

Has there been a loss of property as a result of the alleged Spirit Crime?

Has there been a defamation of character as a result of the alleged Spirit Crime?

Was any physical harm done as a result of the alleged Spirit Crime?

Was a medical professional consulted regarding physical harm?

Was any psychological harm done as a result of the alleged Spirit Crime?

Was a mental health expert consulted regarding psychological harm?

Has access to a service, business, or constitutional right been denied or violated as a result of the alleged Spirit Crime? Please list the issues encountered:

Have any civil liberties been denied or violated as a result of the alleged Spirit Crime? Please specify:

Have religious rights under the First Amendment been violated as a result of the alleged Spirit Crime?

Has there been any forced relocation as a result of the alleged Spirit Crime? Please indicate the circumstances:

Has any sort of imminent danger presented as a result of the alleged Spirit Crime? Please list all safety concerns:

Has there been a denial of education resources as a result of the alleged Spirit Crime? Please specify:

Has there been any coercion or undue influence, duress or cruel actions taken as a result of the alleged Spirit Crime?

Has there been any forced compliance in the workplace as a result of the alleged Spirit Crime?

Has there been unwanted exposure to undesirable circumstances or materials as a result of the alleged Spirit Crime? Please describe the details:

Has purchasing power been limited as a result of the alleged Spirit Crime? For instance, have you been wrongly denied banking privileges? Please be specific:

Have general purpose utilities been denied as a result of the alleged Spirit Crime? This includes gas, electric, water and sewage services. Please specify the services that fall into these categories:

Have food services or the ability to acquire food items been curtailed or completely denied as a result of the alleged Spirit Crime?

### Part 3:

Have publication services been curtailed or completely denied as a result of the alleged Spirit Crime? This could be the ability to publish in physical form like a book, news article, pamphlet, etc. Please specify and explain the reasons to the best of your knowledge.

Have digital services been curtailed or completely denied as a result of the alleged Spirit Crime? This could be any technological system of information interchange such as cable or satellite television, internet service, land line telephone or cellular telephone service, and handicap digital services. Please specify:

Have any social media systems applied sanctions over your content or account privileges as a result of the alleged Spirit Crime? Examples are shadow banning, deliberate reduction in subscriber notification, public view accessibility, and account deletion. Please specify:

### Part 4:

Has legal counsel been acquired or consulted for the alleged Spirit Crime?

Has spiritual counsel been sought out from a corresponding representative of your faith or the belief system of the company or corporation you represent for the alleged Spirit Crime?

Have you been consulted on the alleged Sprit Crime by anyone else or any other company, corporation, group, or organization other than the stopspiritcrime Lamplight Investigative Team?

Do you want to make your information available to the public domain? This is sometimes done to show support and encouragement to victims that have a difficult time coming forward about their assault. You are in no way obligated to do this. All the information from the assessment is completely yours and will be permanently deleted if requested.

In the event that you want to enter this assessment into a legal process you have the option of adding an affidavit declaration.
